

How to Read your NEW Electric Bill

Account Number: You will find this in two places on your bill: here and in the orange box.

Membership Number: This is how we keep track of you and your Capital Credits.

Due Date: Last day to pay without penalty

The Details in the Bill

Your kWh charges: this is the number of kilowatt-hours (kWh or Energy) you use multiplied by the rate of \$0.118046

Monthly Service Charge: Fixed cost per month of \$15.00

Fuel Adjustment: Our rates are based on an ACC approved fuel cost. When the actual cost is lower this becomes a credit. If actual costs are higher it becomes a surcharge.

DSM Surcharge: This is an ACC required surcharge that helps fund programs to help consumers use energy more efficiently. It is applied at \$0.00027per kWh.

ACC Environmental Surcharge: This is also known as the REST charge. This is another ACC program that is based on kWh usage. We collect \$0.00988 per kWh delivered with a maximum monthly amount of \$2.00 for residential accounts.
